A candidate who applied for a Haryana reserved category will be considered first in AIO Category and similarly, candidate applied for reserved Category (SC/ST/BC-A/BC-B/EWS/PH/ESM) will be first considered in HOGC. In case, he is not selected in AIO/Haryana general category, he/she will be considered for the reserve category.
4. All candidates whose names are subject to verification of documents are required to bring one copy of Application Form, self-attested photo copy of all documents as listed below along with all Original Certificates/Documents, Haryana Family ID and caste certificate:

 - h) Parivar Pehchan Patra (Latest Family ID) for Haryana Residents Only.
 - i) Certificate of gap year, if any.
 - j) Migration Certificate (within 30 days of admission).
 - k) Address Proof (Aadhar Card).
5. Candidates after physical verification of documents has to submit the fees upto 29th July 2026, 11:55 pm, through online mode only through your registered Samarth account. No Cash or cheque will be accepted.
