4. Candidates in the merit list, after physical verification of documents, has to submit the fees up to 14th July 2025(Same day), 8:00 pm, through online mode only through your registered Samarth account. No Cash or cheque will be accepted.
5. A candidate who applied for a Haryana reserved category will be considered first in AIO Category and similarly, candidate applied for reserved Category (SC/ST/BC-A/BC-B/EWS/PH/ESM) will be first considered in HOGC. In case, he is not selected in AIO/Haryana general category, he/she will be considered for the reserve category.
