2. The fresh candidates (who have not applied earlier) may submit their online application forms on the admission portal of the Gurugram University (Fill separate application for each specialization, i.e. M. Pharm. (Pharmacology), M. Pharm. (Pharmaceutical Chemistry)

The candidates who have applied earlier in the above-mentioned specialization, may appear for the counseling.

- 3. The merit list will be prepared only for those candidates who have reported on or before 10:00 AM (30th September 2025).
- 4. For admission of vacant seats during open counselling, priority will be given to GPAT-qualified candidates having a valid GPAT score, followed by CUET marks (50 percent cut-off for CUET). The remaining seats will be filled on the basis of the merit of the entrance examination conducted by the Gurugram University, followed by the merit of the qualifying examination, i.e., B. Pharm marks.
- 5. Firstly, the merit list will be prepared for reserved candidates. In case seats remain vacant from the reserved category, they will be converted /offered to General category candidates on the same day, i.e. 30th September 2025.
- 6. The selected candidate has to submit his/her fee on the spot through the University web portal. In case he/she is unable to make the fee payment, the seat will be offered to the next candidate in the merit list. No request will be entertained in this regard under any circumstances.

Note: Due to internal shifting, if any seat is vacated, that vacant seat will be filled from the merit of candidates present on the same day, i.e. 30th September 2025.
