- e) Certificate of Experience, if any, with clear mention of designation, time-period & Pay level/Band with AGP, which must be supported with Salary slip/PF statement/ Form 16/ Bank Statement or any other valid proof of salary paid as claimed. Irrelevant (not as per requisite conditions) experience will not be considered.
- f) Any other document as requisite for the eligibility for respective post.

3. It is clarified that if any of the above requisite documents is not produced at the time of document verification, the respective information/data will not be considered which may lead to ineligibility. No time will be permissible to submit any document later on. If an applicant does not report for document verification, he/she will not be considered for further process of selection.

4. Further, as per the selection criteria mentioned in the advertisement, the weight-age of socio-economic criteria & experience is to be ascertained on the basis of undertaking attached at Annexure-A. If the applicant belongs to such a de-notified tribe (Vimukt Jatis and Tapriwas Jatis) or Nomadic tribe of Haryana which is neither a Schedule Caste nor a Backward Class	Caste/Class certificate issued from the Competent Authority
Experience	Experience (over & above requisite) Certificate along with salary slip/Form 16/Proof of PF/CPF/NPS/ESI Contribution
