Reference: The written tests held on April 18, 2026 for the above referred posts and this office Notice No. GUG/COE/2026/137 dated April 30, 2026 regarding the result of written tests.

In continuation of the above referred notice, it is hereby informed that all the applicants who have qualified the above-mentioned written tests i.e. secured 50% marks (47.5% for DSC/OSC/BCA/BCB/PwBD), have been shortlisted for the next stage of selection process namely Presentation on Teaching Skills and Interview, subject to ascertaining their eligibility during document verification before the Interviews which are scheduled to be held at the University Campus, Sector 51, Gurugram as per following schedule:

1. The list of applicants who have qualified the above-referred written tests has been notified vide University Notice No. GUG/COE/2026/137 dated 30.04.2026. Any applicant who has secured the qualifying marks i.e. 50% marks (47.5% for DSC/OSC/BCA/BCB/PwBD), does not find his/her Roll Number in the said list, he/she may visit the office of the undersigned within 02 working days along with the carbon copy of respective OMR/Answer-sheet, without which no such request/claim shall be entertained.
2. It is clarified that the applicants have been declared qualified on the basis of written test without checking their eligibility. The applicant must satisfy himself/herself about his/her eligibility, before reporting for document verification. The eligibility as per criteria advertised is subject to fulfilling requisite conditions and will be ascertained only during document verification.
3. The shortlisted applicants (as referred to in para 2 above) are advised to report for document verification on the aforementioned date and time and bring the original documents along with one set of self-attested photocopies of the following documents:
 - a. Printout of the online application form.
 - b. 03 Photographs (passport size) with valid Identity & Address Proof having recent clear photo.

- c. Certificate for claiming benefits of reservation (DSC/OSC/BC-A/BC-B/PwBD/EWS/ESM) issued by the Competent Authority as specified by the State of Haryana in the prescribed format only, along with Domicile Certificate and Parivar Pehchan Patra (PPP).
 - d. Matriculation Mark sheet and Certificate.
 - e. Senior Secondary Mark sheet and Certificate.
 - f. Bachelor's (UG) Mark Sheets & Degree Certificate.
 - g. Master's (PG) Mark Sheets & Degree Certificate.
 - h. NET/JRF/SLET Certificate.
 - i. Ph.D. Degree along with certificate w.r.t compliance of UGC Ph.D. regulations 2009/2016 issued by the Competent Authority.
 - j. No Objection Certificate from the Present Employer, wherever applicable.
 - k. Certificate of requisite experience, wherever mentioned.
 - l. Any other relevant document supporting eligibility of the applicant.
4. The qualified applicants who are found eligible during document verification will be required to appear for Presentation on Teaching Skills (Maximum 8 slides, 3-5 minute presentation using PPT) and thereafter for Interview before the Selection Committee. Ineligible applicant will not be considered for further stages of recruitment i.e. Presentation and Interview.
5. Further, it is clarified that if any relevant document is not produced at the time of document verification, the respective information/data will not be considered which may lead to ineligibility. No additional time will be permissible to submit any document later on. If an applicant doesn't report for document verification at scheduled time, his/her candidature will not be considered.
