1. Candidates in merit list, after physical verification of documents has to submit the fees 08/07/2026 upto 5 pm through online mode only. Failure which admission will stand cancelled. In the event of failure to deposit the fee in stipulated date and time, the vacant seats will be offered to the next candidate(s) in the merit list.
5. A candidate who applied for a Haryana reserved category will be considered first in AIO Category and similarly, candidate applied for reserved Category (SC/ST BC-A/BC-B EWS PHE/SM) will be first considered in HGC. In case, he is not selected in AIO/ Haryana general category he/she will be considered for the reserve category.
6. Candidates belonging to the Haryana SC category who have not specified their sub-category (SC Other SC Deprived) in the application have been provisionally included in the merit list. The final sub-category will be determined during document verification based on the valid caste certificate submitted by the candidate.
