1. All candidates who have applied for admission to the M. Pharm. programme and possess a valid GPAT/CUET score card (GPAT-qualified) are hereby informed to attend the counselling on 23rd July 2026.
2. In CUET, a minimum 50 percentage/percentile is required. Priority will be given to GPAT-qualified candidates.
3. The allotment of seats shall be made strictly on the basis of the candidate's merit, applicable reservation category, and the availability of seats in the respective category, in accordance with the University admission rules and applicable guidelines.
4. The admission will be provisional and subject to verification of original documents.
5. The candidates have to report in the Department of Pharmaceutical Sciences (**Academic Block-1, Ground floor, Pharmacy office**), Gurugram University, Gurugram (Sector 87) at 9:30 AM on 23/07/2026.
6. Applicable admission fees should be paid by 05:00 PM on 23/07/2026, failing which admission will stand cancelled. In the event of failure to deposit the fee by the stipulated date and time, the vacant seat(s) will be offered to the next candidate(s) in the merit list.
7. All SC category candidates need to submit a duly filled and signed undertaking as per the sample proforma available in Information Brochure **Appendix 'T'**.
8. A candidate who has applied for a Haryana reserved category will be considered first in All India category and similarly, candidate of reserved category (SC/ST/BC-A/BC-B/EWS/PH/ESM) will be first considered in Haryana general category. In case he is not selected in the general category, he/she will be considered for the reserve category.

2. The students have to appear physically in counselling for admission to M. Pharm. along with all relevant original documents as mentioned in the Information Brochure (2026-27).

4. The candidates with re-appear(s) in the qualifying examination will not be allowed admission to the Programmes.
