This is to notify all concerned that Open Counselling for the **Master of Pharmacy (M. Pharm.)** Programme against vacant seats will be conducted on **31 August 2026 (Monday)** in the Gurugram University campus (Sector 87, Gurugram).

All candidates must report in person to the Department of Pharmaceutical Sciences (Academic Block-1, Ground floor, Pharmacy office), Gurugram University, Gurugram (Sector 87) at 9:30 AM on 31/08/2026.

Note: Candidates reporting after 10:30 A.M. (dated 31/08/2026) shall not be considered for admission.

Important Instructions:-

1. The open counselling for the above-mentioned programme will be conducted against the vacant seats.

2. The fresh candidates (who have not applied earlier) may submit their online application forms on the admission portal of Gurugram University (Fill separate applications for each specialization, i.e. M. Pharm. (Pharmacology), M. Pharm. (Pharmaceutical Chemistry), M. Pharm. (Pharmaceutics))

3. No entry of online applications will be entertained after 10:00 AM for the Open Counselling (31 August 2026). The merit list will be prepared only for candidates who report on or before 10:30 AM on 31st August 2026.

4. For admission of vacant seats during open counselling, priority will be given to GPAT-qualified candidates having a valid GPAT score, followed by CUET marks (50 percent cut-off for CUET). The remaining seats will be filled based on the merit of the entrance examination conducted by Gurugram University, followed by the merit of the qualifying examination, i.e., B. Pharm marks.

5. Firstly, the merit list will be prepared for reserved candidates. Later, in case seats remain vacant from the reserved category, they will be converted /offered to Haryana General Open Category/All India Open category candidates, on the same day, i.e. 1st Open counselling.

7. The selected candidate has to submit his/her fee on the spot through the University web portal. In case he/she is unable to make the fee payment, the seat will be offered to the next candidate in the merit list. No request will be entertained in this regard under any circumstances.
