**Note:**

1. He/She has to **submit his/her fees same day of appearing in the merit list on or before 5:00 PM**. In case the students in merit list do not submit the fees the seat will be offered to next candidate in the merit list.
2. In case candidate belongs to the SC Category and is having family income less than Rs. 2.5 Lacs per annum then he/she does not have to deposit the fees on admission. He/She will be required to submit an undertaking alongwith **valid Income certificate** in format on same day of appearing in the merit list **on or before 5:00 PM** to be procured from the Chairperson of the Department concerned:-

3. All admissions are provisional subject to verification of documents and approval of competent authority.
4. The Chairpersons will prepare category-wise merit-lists and offer admission accordingly. In case seats still remain vacant, in any sub-category, inter-se transfer of seats as per Clause 9 page 43 of the Information Brochure shall be made. Similarly, if any seat in SC category remains vacant for want of sufficient number of candidates, the same will be filled up by offering to deprived SC candidates and vice-versa. It is only after exhausting the merit list of reserved category candidates, that the vacant seats shall be converted in Open Category and admission be made accordingly by the Chairperson concerned.
5. The admissions will be closed as soon as all the seats are filled.
