It is to notify for information of all concerned that Open Counseling for the Master of Pharmacy (Pharmaceutical Chemistry) Programme against two vacant seats will be conducted on 5th November 2024 in the University campus.

Time of reporting (Department of Pharmaceutical Sciences): 9:30 AM

Important Instructions:-

1. The open counseling for the M. Pharm. (Pharmaceutical Chemistry) programme's will be conducted against the two vacant seats.
2. The fresh candidates (who have not earlier applied) may submit their online applications from the admission portal of the University <https://gurugramuniversityadm.samarth.edu.in/>
3. **No entry will be entertained after 10:30 AM for the Open Counseling. The merit list will be prepared only for those candidates who have reported on or before the 10:30 AM.**
4. For admission of vacant seats during open counselling, first priority will be given to GPAT qualified candidates having valid GPAT score followed by CUET marks (50 percent cut-off for CUET). The remaining seats, will be filled from the merit of entrance examination conducted by the Gurugram University followed by merit of qualifying examination i.e., B. Pharm marks.
5. The selected candidate **has to submit his/her semester fee on the spot through University webportal.** In case he/she is unable to make the fee payment, the seat will be offered to the next candidate in the merit list. **No request will be entertained in this regard in any circumstances.**
6. The admission for the open counseling will be made by the concerned Department Chairperson.
