IMPORTANT INSTRUCTIONS

All applicants are required to apply in the prescribed format of the application form available on the University website with complete & correct information and attachments. The applicant will be solely responsible for the authenticity of the submitted information. The applicants are required to read these details before filling up the form:-

- 1. The candidate must be citizen of India.
- 2. For the post(s) advertised for reserved categories, the applications of only Haryana resident's shall be entertained. The application for such reserved posts of residents other than Haryana, if any, shall be deemed rejected and considered only for unreserved post, if advertised in this advertisement.
- 3. Applicants should possess the prescribed qualifications and experience as on the closing date of application as prescribed by the University from time to time for the respective post. The prescribed essential qualifications and experience indicated at Annexure A are bare minimum. Possession of the same will not make any candidate to be shortlisted for further written test / interview.
- 4. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to SC/ST/BC-A/BC-B (Non-creamy Layer) and PwBD of Haryana for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 5. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 Sept, 1991.
- 6. The scrutiny of applications will be done on the basis of the information filled and documents uploaded by the applicants and thus remain provisional till the same gets verified. If on verification, any information/document is found to be incorrect at any stage (even after selection) the applicant will be liable for prosecution as per rules.
- 7. For the post of Professor and Associate Professor, all the parts of the Application form Part A, B & C are required to be filled. Incomplete applications and those received late on any account, including postal delay, or/ and without the prescribed fee, shall be summarily rejected.
- 8. The applicant who obtained his/her degree(s), which is/are essential for eligibility, from Singhania University (Rajasthan), EIILM University (Sikkim), Manav Bharti University (Himachal Pradesh), Vinayaka Mission University (Sikkim), Global Open University (Nagaland) and Vinayaka Mission University, Salem, Tamilnadu vide notification. D.O No. F 5- 4/2014 (CPP-I/PU) dated 05.08.2014 and D.O No. F 10-6/2011 (PS) Misc. dated 06.07.2015 havebeen declared ineligible for appointment in the University. However, his/her candidature will be considered for the appointment in the University if they upload the certificate as per Annexure titled "Certificate in respect to Ph.D. from main campus and supervisor eligibility as per UGC norms", in addition to Annexure titled "For the candidates who registered for PhD Programme prior to July 11, 2009" or Annexure titled "For the applicant who have registered for Ph. D. Program on or after July 11, 2009", whichever is applicable, from concerned universities. Such applicant having degrees issued by the above Universities through Distance Education Mode will have to upload the certificate duly verified from the Distance Education Council/Distance Education Bureau, New Delhi (Annexure-B).

- 9. In case of applicant, who is otherwise eligible, the benefit of such degree(s) towards marks/weightage/score would also be subject to the submission of certificate(s) as per Annexures mentioned in point no. 08 above.
- 10. University reserves the right of deciding the discipline(s) as concerned/allied/relevant while scrutinizing the applications. However, the candidate if any shall have to submit the equivalency certificate of course with the required course for eligibility duly issued by the concerned regulatory body i.e. AIU etc.

11. RESERVATION:-

- (i) In case of non-availability of suitable candidate under horizontal reservation category of ESM under any vertical Category of Gen/SC/BC/EWS for which post(s) are reserved but no ESM/DESM candidate of said horizontal category is available, the candidate from the respective vertical category will be considered for that post. Benefit of reservation of ESM/DESM will be applicable as State Govt. Instructions issued time to time.
- (ii) The benefit of reservation will be given only to those SC/BC/ESM/DESM/EWS/PwBD category candidates who are domiciles of Haryana State.
- (iii) The women candidates seeking reservation under any reserved category are required to submit the (last Certificate issued by the Competent Authority from Parental Side (Father's side) only. It should be noted that Certificate from in-laws (Husband Side) will not be entertained.
- (iv) It is clarified that State Government has decided to specify the criteria for exclusion of persons with the Backward Classes as Creamy Layer, regarding reservation in Services and Admission as per notification No. 491 – SW (I) 2021 dated 17.11.2021. Therefore, the candidates belonging to BC-A/BC-B category of Haryana are required to submit latest/updated certificate as per notification No. 22113212013-1GS-III dated 22.03.2022 (available on the website of C.S. Haryana i.e. http://csharyana.qov.in) issued by the Competent Authority during 2023-24.
- (v) The candidates of reserved categories of Haryana for which no post is available /reserved, if any, can apply for the posts of General category, if he / she fulfils all the eligibility conditions as meant for General category candidates, except fee. Such candidates must attach copy of their caste certificate for claiming fee concession.
- (vi) In case, the vacancies earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancy will be filled from General/Unreserved category.
- (vii) The reserved category candidates belonging to other States will compete against the posts meant for General/Unreserved category and will be considered as General/Unreserved category candidates.
- 12. The candidate applying for the post have to submit Application Form by speed / registered post on or before last date notified by the University, to the Deputy Registrar (Estt.), Gurugram University, Mayfield Garden, Sector-51, Gurugram-122003 along with self-attested visible/readable photocopies of certificates/testimonials/reprints of research publications, title page(s) with ISBN/ISSN and content page(s) of each Book / Journal / Proceeding in which the publication(s) under reference is /are published must be numbered in sequence.
- 13.No fee/document or both shall be entertained after last date/time of receipt of application. Candidates applying for multiple posts will be required to apply and pay separate fee against each post applied.
- 14.a) The candidate who are already in employment of Government Departments, Universities, Educational Institutions, Public Enterprises, Quasi-government Organizations etc., whether in a permanent or temporary capacity, must apply for the post through proper channel.
- b) Such candidate shall submit an advance copy/copies of their application directly to the University on or before the last date of receipt of application as notified.
- c) If there is delay in the forwarding of the application, the candidates should, if and when called for

interview, bring along the written permission of the employer, permitting them to appear before for interview. In absence of a "No Objection Certificate", the candidates may not be interviewed.

- 15. Any of the posts advertised may be withdrawn from being filled-up at any time without assigning any reason at any stage and fees will be refunded by the University to such applicants.
- 16. The application form should be duly/properly filled in. The candidates will have to meet minimum API score required for the said post, wherever applicable and should calculate the API score accurately and justify their claim on their own by enclosing necessary documentary evidence in the support.
- 17. The applicant who have registered for Ph.D Programme prior to July 11, 2009 and have beenawarded degree, are required to produce a certificate for the fulfillment of the conditions tobe certified by the Registrar or Dean Academic Affairs of the University concerned in format appended at **Annexure-C**.
- 18. The applicant who have registered for Ph.D Programme on or after July 11, 2009 are required produce a certificate for the fulfillment of the provisions of the UGC (minimum standardsand procedure for award of Ph. D. degree) Regulations, 2009/2016 as the case may be to be issued by the Vice-Chancellor/Pro-Vice-Chancellor/Dean, Academic Affairs/Dean, (Research & Development) of the concerned Universities as per Annexure-D.
- 19. Candidates applying for the post of **Professor** and **Associate Professor** are required minimum API score of 120 (One Hundred Twenty) and 75 (Seventy Five), respectively (wherever required). The candidates should calculate and justify on their own, enclosing necessary documentary evidence in support of their claim and should refer to guidelines / methodology for calculating Academic & Research score based on Performance Based Appraisal System appended at Annexure- E.
- 20. The Criteria for selection/ shortlisting of applicants for post of Professor and Associate Professor is placed at **Annexure- F.**
- 21. Candidates to be called for interview, especially even where specializations are mentioned, will be decided by the Screening Committee whose recommendations for one being called (or not being called) for interview shall be final. Thus, only those who possess the required specialization(s) and fulfilling the minimum eligibility conditions need to apply.
- 22. One's claim for a given specialization must be supported by credible evidence in terms of research publications in peer reviewed Research Journals, and/or teaching experience in the relevant field/ specialization for at least five years to be properly certified and authenticatedby the appropriate authority/Head of the institution. Applications found lacking in any such respect(s) are liable to be ignored/ rejected. Those declared ineligible will not be informed of their status being as such. Candidates are thus advised to make sure before applying thatthey are indeed eligible for a given post both in terms of minimum eligibility conditions andthe required specialization attached therewith, if any.

Note:-

- i) EWS category candidate applying against Gen. Posts and wants to avail to fee concession must attach EWS certificate valid for the year 2023-24, otherwise they have to pay full fees as meant for male candidates of unreserved category.
- ii) Fee once paid shall not be refunded under any circumstances.

24. Provision of assistance of scribe to Persons with Benchmark Disabilities:-

As per the guidelines issued by the Department of Empowerment of Persons with Disabilities under Ministry of Social Justice & Empowerment, following facilities will be made available to Persons with Benchmark Disabilities:

- i) In case of persons with benchmark disabilities in the category of blindness, locomotor disability (both arm affected-BA) and cerebral palsy, the facility of scribe or compensatory time of 20 minutes per hour will be provided by the University, if desired by the candidate. Candidates will be provided with Scribe only if they apply for availing the scribe facility in online application form. However, in case there is no provision is available for apply such facility in online application then such applicant has to submit his/her application while submitting the hard copy of printout of online application to the university.
- ii) In case of remaining categories of persons with benchmark disabilities, the provision of scribe will be provided on production of a certificate at the time of examination to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his/ her behalf, from the Medical Board consisting of Chief Medical Officer and at-least two other members of a Government health care institution as per Performa at **Annexure-H**. Candidates will be provided with Scribe **or** compensatory time of 20 minutes per hour will be provided, if desired by the candidate, only if they apply for availing the scribe facility in online application form and upload the certificate with application form as per **Annexure -H**.
- iii) The qualification of the scribe should be one step below the minimum qualification prescribed for the post. The candidates with benchmark disabilities opting for scribe shall be required to submit details of the scribe at the time of examination as per proforma at Annexure-I. In addition, the scribe has to produce a valid ID proof in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will be submitted along with proforma at Annexure-I.
- iv) Scribe should not be a candidate of the same examination. If a candidate is detected as assisting another PwBD candidate as scribe in this examination, then the candidatures of both the candidates will be cancelled.
- v) No attendant other than the scribe for eligible candidates will be allowed inside the examination hall.
- vi) The PwBD candidates who have availed the facility of Scribes shall be deemed to have availed benefit of relaxation and must produce relevant documents for the eligibility of scribe when called upon to do so by the University.
- 25. The number of post may be increased or decreased including complete withdrawal, without assigning any reason. The University reserves the right not to fill or withdraw any or all of the advertised posts without assigning any reason.
- 26.Candidates are advised to visit the University website regularly for any update/new instructions/ Scrutiny/Selection process including the interview schedule.
- 27. Any claim of teaching experience will be considered strictly as per the notified State Govt. guidelines,

available at Annexure-G. The certificate of experience must be submitted in accordance with the same. It will have to be supported with Form 16/Bank Statement/ITR etc.

- 28. The time taken by candidates to acquire M.Phil and / or PhD Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions. Further, the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experiencefor the purpose of direct recruitment.
- 29. The post-doctoral experience shall be counted only if the candidate has worked on a post- doctoral fellowship of some government funded agency like UGC/ICSSR etc. Such Experience shall be counted only for the original term provided under the relevant rules.
- 30. All columns must be filled in the application form. No column should be left blank, instead it should be marked "N.A." wherever not applicable. The documents enclosed with the application form should be self-attested and page numbered.
- 31.No TA/DA in connection with the submission of application form or appearing in the interview will be paid to the candidate.
- 32. Age Limit: Maximum 55 years. No relaxation will be admissible.
- 33. The candidates found eligible by the Screening Committee and short listed by the University will be called for interview. Those declared ineligible will not be informed about their status.

For avoidance of doubt, it is hereby clarified that, If class or Division is not declared at the Bachelor's or Master's Degree levels, an aggregate of >=60% or equivalent cumulative Grade Point Average (CGPA) is to be considered as equivalent to first class. In case of CGPA awarded to the candidates on a 10- point Scale, the candidate need to obtain and submit the table of equivalence from the concerned university along with the application form.
- 35. Extract of the State Govt. Instructions contained in DGHE vide memo dated 11.11.2022

10.0 Counting of Past Services for Direct Recruitment and Promotion under CAS

Previous regular service, whether national or international, as Assistant Professor, Associate Professor or Professor or equivalent in a University, College, National Laboratories or other scientific/professional organisations such as the CSIR, ICAR, DRDO, UGC, ICSSR, ICHR, ICMR and DBT, etc including Govt. Aided Private Colleges of Haryana should be counted for the direct recruitment and promotion under the CAS of a teacher as Assistant Professor, Associate Professor, Professor or any other nomenclature, provided that:

- (a) The essential qualifications of the post held were not lower than the qualifications prescribed by the UGC for Assistant Professor, Associate Professor and Professor, as the case may be.
- (b) The post is/was in an equivalent grade or of the pre-revised scale of pay as the post of Assistant Professor (Lecturer) Associate Professor (Reader) and Professor.
- (c) The concerned Assistant Professor, Associate Professor and Professor should possess the same minimum qualifications as prescribed by the UGC for appointment to the post of Assistant Professor, Associate Professor and Professor, as the case may be.
- (d) The post was filled in accordance with the prescribed selection procedure as laid down in the Regulations of the University/State Government/Central Government/ Institutions concerned, for such appointments and the candidate has applied for direct recruitment through proper channel only.
- (e) The previous appointment was not as guest lecturer for any duration.
- (f) The previous Ad-hoc or Temporary or contractual service (by whatever nomenclature it may be called) shall be counted for direct recruitment and for promotion, provided that:
 - (i) the essential qualifications of the post held were not lower than the qualifications prescribed by the UGC for Assistant Professor, Associate Professor and Professor, as the case may be
 - (ii) the incumbent was appointed on the recommendation of a duly constituted Selection Committee/Selection Committee constituted as per the rules of the respective university and the incumbent was selected to the permanent post in continuation to the Ad-hoc or temporary or contractual service without any break;
 - (iii) the incumbent was drawing total gross emoluments not less than the monthly gross salary of a regularly appointed Assistant Professor, Associate Professor and Professor, as the case may be; and
- (g) No distinctions shall be made with reference to the nature of management of the institution where previous service was rendered (private/local body/Government), while counting the past service under this clause.
