02.	In case the seats remains vacant after open Counseling on <b>29.09.2025</b> may be allowed on merit basis by the Principals concerned with late fee of <b>₹ 1000/-</b> to be remitted to the University by the College/Institute alongwith Registration Return.	<b>30.09.2025 to 10.10.2025</b>
03.	Late admissions may be allowed on merit basis by the Principal/Director concerned with late fee of <b>₹ 2000/-</b> to be remitted to the University by the College/Institute alongwith Registration Return.	<b>11.10.2025 To 20.10.2025</b>
04.	The admission in special cases may be allowed with the approval of Vice Chancellor, on the request of Principal/Director of the college/institute, if the seats remains vacant, with late fee of <b>₹ 5000/-</b> per student (to be remitted to the University) on the basis of merit.
