Sr. No.	Particulars	B.Ed./M.Ed. Programme
01.	Physical/Open Counselling at the college level, if required (Fee to be deposited in the allotted institute on the same day of counselling)	Upto 30.09.2026
02.	In case the seats remains vacant after open Counseling on 30.09.2026 may be allowed on merit basis by the Principals concerned with late fee of ₹ 1000/- to be remitted to the University by the College/Institute alongwith Registration Return.	01.10.2026 to 02.10.2026
03.	Late admissions may be allowed on merit basis by the Principal/Director concerned with late fee of ₹ 2000/- to be remitted to the University by the College/Institute alongwith Registration Return.	03.10.2026 To 05.10.2026
04.	The admission in special cases may be allowed with the approval of Vice Chancellor, on the request of Principal/Director of the college/institute, if the seats remains vacant, with late fee of ₹ 5000/- per student (to be remitted to the University) on the basis of merit. The list of students admitted be sent alongwith Registration Return.	06.10.2026 To 07.10.2026
05.	There will be no admission by the College/Institute after the above schedule i.e. 07.10.2026 in order to maintain the Statutory Provision of necessary teaching days per semester. If the number of teaching days falls short due to some unforeseen reasons, it shall be the responsibility of the Principal/Director to make good the loss by taking extra classes.
