1. All candidates who have applied for admission to the M.Sc Forensic Science programme are hereby informed to attend the counselling on 06.08.2026.
2. In CUET, a minimum 50 percentage/percentile is required followed by the merit of the qualifying exam.
3. The allotment of seats shall be made strictly on the basis of the candidate's merit, applicable reservation category, and the availability of seats in the respective category, in accordance with the University admission rules and applicable guidelines.
4. The admission will be provisional and subject to verification of original documents.
5. The candidates have to report in the Department of Pharmaceutical Sciences (**Academic Block-1, Ground floor, Pharmacy office**), Gurugram University, Gurugram (Sector 87) at 9:30 AM on 06/08/2026.
6. Applicable admission fees should be paid by 05:00 PM on 06/08/2026, failing which admission will stand cancelled. In the event of failure to deposit the fee by the stipulated date and time, the vacant seat(s) will be offered to the next candidate(s) in the merit list.
7. All SC category candidates need to submit a duly filled and signed undertaking as per the sample performa available in Information Brochure Appendix 'T'.
8. A candidate who has applied for a Haryana reserved category will be considered first in All India category and similarly, candidate of reserved category (SC/ST/BC-A/BC-B/EWS/PH/ESM) will be first considered in Haryana general category. In case he is not selected in the general category, he/she will be considered for the reserve category.
