**Subject: - Provisional Recognition of College of Physiotherapy, Gurugram University, Gurugram for B.P.T and M.P.T Course for the academic session 2021-22.**

Kindly refer to the subject cited above.

As you are aware that the inspection of your institution was conducted on 08.10.2021 by the inspection team constituted by Haryana State Council for Physiotherapy for the purpose of grant of recognition of the courses mentioned in the subject. The main deficiencies pointed out by the inspection team are as under:

## 1. Infrastructure:

- i) There is no Hostel building for boys and girls and there is no separate building for college of physiotherapy.
- ii) There is no equipment's in medical physics and fundamentals of electrotherapy lab.
- iii) There is deficiency of equipment's in Exercise tolerance and fitness lab, functional diagnostic lab and Biomechanics and Kinesiology lab.
- iv) M.P.T Specialized labs were found deficient
- v) Anatomy and Physiology labs were found deficient.

## 2. Faculty:

- i) There is major deficiencies of staff in core subjects only 09 Physiotherapy faculty is available out of which 02 are regular as Assistant professor, 01 Demonstrator and 06 on daily resources.
- ii) Medical subjects are being taught by physiotherapist only.

On the basis of inspection report, **your institution is hereby granted provisional recognition for academic session 2021-22, subject to the condition that the institute will remove all the deficiencies before the commencement of next academic session and the compliance report shall be submitted to the Council office up to 31.03.2022.** You are requested to apply to Council after removing all deficiencies for recognition for next academic session 2022-23. Further, for intake of seats, the university is requested to apply for fresh NOC to Department of Medical Education and Research for the purpose of admission in academic session 2021-22.

You are hereby requested to ensure that the Institute shall abide by all the instructions issued by the Department of Medical Education and Research and the affiliating University from time to time, and shall function as per the provisions of Haryana
