



Agenda 4: Introduction of Certificate Course in Cyber Law and Labour Law.


Action Taken: The Board of Studies gave its consent for introducing the three-month (30 hr) certificate course in cyber law and labour law.

Action Taken: The Board of Studies has approved the following distribution of supervisors to the research scholars.


