- v. The Title of Subject Indian Penal Code, Criminal Procedure Code and Evidence Act now will be substituted by Bhartiya Nyaya Sanhita, Bhartiya Nagarik Suraksha Sanhita and Bhartiya Sakshya Adhinyam respectively

- vi. The title of 'Alternative Dispute Resolution' was renamed as 'Arbitration, Mediation & Conciliation'.

- viii. Discussion on reducing the number of papers in the 6th/ last semester.
