


The board after detailed discussion resolved and passed the syllabus of all the five programs with the following changes:

- For MBA Programme:
 - a. Summer Internship Report evaluation should be internal only. It can be evaluated through presentation and viva.
 - b. Suggested readings should be enriched by latest and renowned books.
 - c. Number of Discipline specific elective subjects should be reduced to two per specialization applicable in third and fourth semester.
- For MBA Integrated Programme:
 - a. The overall average credits per semester should range from 23 credits to 24 credits.
 - b. The NSE certification needs to be replaced with NISM certificate courses.
 - c. Python, C++, R can be taught as a Skill Enhancement Course.
 - d. Corporate accounting needs to be revised e.g 'Insurance and Banking Accounts' replaced by Merger Acquisition valuation.
 - e. 'Activity based costing' should be included in 'Accounting for Managerial Decisions' course.
- PG Diploma in Business Analytics:
Approved without any change
- PG Diploma in Digital Marketing:
Approved without any change
- MBA (Hospitality Management) :
Approved without any change

The board after detailed discussion resolved that the proposal can be accepted principally and the department can explore related modalities further.


