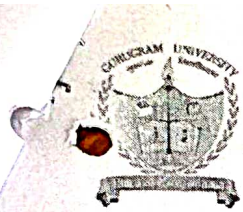

**Item No 1:** To discuss and seek approval/advice on the revised syllabus of Pre-Ph. D. Course Work applicable from the Academic session 2021-22 onwards.

The Board, after detailed discussion resolved that the revised syllabus for Pre Ph.D. course work (Annexure I) be approved.
