Item No.AC/12/11: To Note the Action Taken by the Executive Council regarding Provisional Affiliation to State Institute of Advanced Studies and Research (SIASTE), Gurugram.

It is submitted that the matter of granting Provisional Affiliation to the State Institute of Advanced Studies in Teacher Education (SIASTE), Gurugram was considered in the 8th meeting of the Academic Council held on 24.01.22 resolved to bring up the said item in the next meeting of the Academic Council along with status of NCTE approval.

In the meanwhile, on the complaint of Adv. Dharmender, regarding non submission of NCTE approval, the matter was referred to the Executive Council by the Vice-Chancellor and the Council resolved to issue show cause notice to the institute for non-compliance of submission of NCTE approval. The reply of the Institute was referred to the Executive Council and the Council constituted the committee to examine the issues and recommend suitable course of action.

On the basis of the proceedings of the committee and approval of the same by the Executive Council in its 29th meeting held on 19.01.24, the Institute was granted provisional affiliation for academic session 2022-23 and 2023-24 subject to necessary regulatory approval from NCTE. The matter is now to be placed before the Academic Council to note the action taken by the Executive Council regarding granting of Provisional Affiliation to SIASTE, Gurugram.

Item No.AC/12/12: To Note the sanction of new teaching posts and approve the recommendations w.r.t. allocation of these new posts and re-allocation of existing vacant posts as per reservation norms.

It is brought to the notice that the State Government has recently sanctioned 97 teaching posts as under. A committee was constituted to recommend the suitable allocation of these new and existing vacant posts to allot/re-allot to various disciplines and categories to comply the applicable reservation norms. The committee has submitted its recommendations which are placed at (**Annexure-‘I’**). Accordingly, the above recommendations are placed before the Council for consideration and approval.

Item No.AC/12/13: To Note List of Students for Awarding Gold Medals in its Second Convocation of the University.

It is submitted that first Convocation of the University was organized on 21.09.21. Now, University is going to conduct its Second Convocation for awarding UG and PG degrees for all the students of University Teaching Departments, passing out in the year 2023. As per Ordinance VI-Scholarship, Stipends, Medals and Prizes of the University Calendar Volume-1, The University shall award annually Medals to all students who obtain First Class First Position in the order of merit in the various University Examinations held at the end of his course. Further, the Academic Council in its 6th meeting held on 17.09.21 has resolved that in future the Vice Chancellor be authorized to approve the list of the students who are awarded Medals for the Degree(s)/Diploma(s) and other examination(s) conducted by the University. Accordingly, list of students for gold medals of all courses, passing out in the year 2022 and 2023. The list of students has already been approved by the Vice Chancellor and same is placed at (**Annexure 'J'**).

Item No.AC/12/14: To Note that the University is conducting its Second Convocation for Awarding UG and PG Degrees to students of University Teaching Departments.

It is submitted that first Convocation of the University was organized on 21.09.21. Now, University is going to conduct its Second Convocation for awarding UG and PG degrees for all the students of University Teaching Departments, passing out in the year 2023. It is further submitted that Academic Council in its 6th meeting held on 17.09.21 has resolved that in future the Vice Chancellor be authorized to approve the list of the students who are to be admitted/awarded to the Degree(s)/Diploma(s) and other examination(s) conducted by the University. Approximately 600 students are eligible for awarding degrees in the Second Convocation and list has already been approved by the Vice-Chancellor.

Item No.AC/12/15: To ratify the Action Taken by the Vice-Chancellor in approving the Dress Code and Academic Costumes for the 2nd Convocation.

It is submitted that University is going to conduct its Second Convocation for awarding UG and PG degrees for all the students of University Teaching Departments, passing out in the year 2023. It is further submitted that on the proposal of the Examination Branch, the Vice Chancellor by virtue of the powers vested to him under clause 11(7) of the University Act has approved the Dress Code and Academic Costumes (Copy attached) for Guests/AC/EC/Court members, Staff and Students of the University for the second Convocation, in anticipation approval of the Academic Council.

The matter is now placed before the Academic Council to ratify the action taken by the Vice-Chancellor in approving the dress code and academic costumes for the second Convocation.
