- i) In case the seats remains vacant after open Counseling on **12.09.2025**, late admissions from **13.09.2025 to 19.09.2025** may be allowed on merit basis by the Principals concerned with late fee of ₹ **1000/-** to be remitted to the University by the College/Institute alongwith Registration Return.
- ii) Late admissions from **20.09.2025 to 25.09.2025** may be allowed on merit basis by the Principal/Director concerned with late fee of ₹ **2000/-** to be remitted to the University by the College/Institute alongwith Registration Return.
- iii) The admission in special cases may be allowed with the approval of Vice Chancellor from **25.09.2025 to 30.09.2025**, on the request of Principal/Director of the college/institute, if the seats remains vacant, with late fee of ₹ **5000/-** per student (to be remitted to the University) on the basis of merit. The list of students admitted be sent alongwith Registration Return.
- iv) Candidates who have compartment/re-appear in one or more paper(s) in the qualifying examinations shall not be allowed admission in 1st Semester/Year of the course in any case.
- v) There will be no admission by the College/Institute after the above schedule i.e. **30.09.2025** in order to maintain the Statutory Provision of necessary teaching days per semester. If the number of teaching days falls short due to some unforeseen reasons, it shall be the responsibility of the Principal/Director to make good the loss by taking extra classes.
- vi) **The list of all the students so admitted alongwith Registration Return be uploaded online on the web portal of University as per schedule notified by R&S branch to the concerned College(s).**

Note:

- **The schedule of admission given above is tentative and subject to change.**
- The student has to pay the annual fee at the allotted college/institute at the time of reporting in allotted college/institute after physical document verifications. In case he/she did not deposit the same, the candidature will be offered to the next person in merit list/waiting list in 2nd Merit list.
- Students are advised to check the eligibility and admission criteria before filling the online admissions forms.
- If student get allotted admission in upgraded choice of college in 2nd Merit list, the provisional admission in college during 1st counseling shall be considered as cancelled and his annual fee shall be refunded to candidate in due course of time. He/she has to deposit the annual fee again in upgraded college/institute during second counseling.
- Candidates who have compartment/re-appear in one or more paper(s) in the qualifying examinations shall not be allowed admission in 1st semester of the course in any case.
- There will be no admission in any College/Institute after the above schedule in order to maintain the Statutory Provision of necessary teaching days per semester. **If the number of teaching days falls short due to some unforeseen reasons, it shall be the responsibility of the Principal/Director to make good the loss by taking extra classes.**

1. Reduction/relaxation of 5% marks in the eligibility conditions in all the programs shall be granted to the Scheduled Caste candidates. This percentage shall be calculated as per the example given below:-
2. Out of 100 marks needs to less = $(5/100) \times 100 = 5$

Admission Process

1. The candidates are advised to read the Admission Guidelines carefully before filling the online Application Form.

The application fees of **Rs. 1000/- for General Category and Rs. 250/- (non-refundable)** for Scheduled Caste, Backward Class of Haryana, Differently Abled Person and Economically Weaker Sections (EWS) of Haryana for each programme shall be paid by the applicant online.
3. Each candidate has to apply separately for each program.
4. **Student has to fill the choices of colleges very carefully. No changes in Choices will be allowed after submission of application form. The college will be allotted on the basis of choice filled by candidate according to merit list.**
5. The Candidate shall be personally responsible in case, he/she is not eligible to apply as per the given eligibility criteria.

CHAPTER-IV

GUIDELINES FOR APPLICANTS AND COLLEGES

Guidelines for Applicants

- 1. Aadhar card and Parivar Pehchan Patra/Family Id (mandatory for Haryana residents).**
2. Candidate is advised to carry scanned copies of all relevant documents as mentioned in Chapter 1.
- 3. Choice filling cannot be changed; it will be as filled in application form.**
4. General category students can now opt for EWS (Economically Weaker Section) quota within the Haryana General Quota. However, they need to upload the required certificate **(Appendix F)** for the same.
5. Online Documents Verification shall be carried out by **Admission Committee of colleges.**
6. If any discrepancy is found in the submitted application form of student due to any reason during the online verification process, the verifier (college) will mark the application as **'RESUBMISSION'** and enter the reason with Remarks Column. A SMS and Email will be sent to the applicant with remarks to clear the objection within prescribed time frame. The applicant will be required to make necessary corrections on the University online admission portal by logging in his/her account. If candidate fails to remove the discrepancy or resubmit the application within prescribed time frame the form will be rejected.
- 7. If any document of a student is rejected due to any reasons during the**

process of online verification, a SMS and Email will be sent to the applicant with the remarks to clear the objection within prescribed time frame. The applicant will be required to make necessary corrections on the University online admission portal by logging in his/her account. **If candidate fails to remove the discrepancy or resubmit the application within prescribed time frame the form will be rejected.**

8. Merit lists shall be prepared after considering marks of qualifying examination and as per State Govt. Reservation Policy.
9. In case of CGPA, convert it into marks/percentage as per the norms of Board/University.
10. The candidate shall be allotted the seats according to merit list and reservation policy, and preferences (choice of colleges) filled by the students.
11. If a candidate got the admission in the first choice as filled by the applicant he/she will not be allowed to take part in the second counseling.
12. The candidate shall report to the allotted college on the date as per admission schedule with all relevant original documents for the physical verification.
13. After physical verification the college will verify the same on University web portal. The student has to submit his/her annual fee at the allotted college/institute at time of reporting in allotted college/institute on the same day or as mentioned in admission schedule.
14. In case student fails to produce original documents the admission shall be treated as cancelled.
15. After appearance of name of student in merit list, he/she will have to make **the**

payment of admission charges/fee at the allotted college/institute at time of reporting in allotted college/institute as per admission schedule.

16. The students will be initially given provisional admission only, subject to the verification of their documents by the College/Affiliating University. In case of any discrepancy, the college is authorized to cancel the provisional admission of the student or change his/her stream/subjects subject to availability of seats. Even the College / University can cancel any such admission wherever the information provided by the students is found to be fictitious /bogus at any stage and the student concerned will be held solely responsible for this.
17. In case student fail to deposit his/her fee the allotted seat will be treated as vacant seat and will be offered to the next candidate during the preparation of second merit list.
18. Before preparation of 2nd merit list, provisionally admitted student will be given a chance if he/she is not satisfied with the allotted college (the applicant did not get his first choice) and want to consider his/her candidature for upgraded college as per his/her choice. This choice to participate in 2nd counseling is to be filled online through University web portal within prescribe time frame only.
19. In 2nd merit list, all the candidates (i) who did not get any seat during 1st merit list (ii) those who got seat allotted but could not get admitted due to any reason and (iii) candidates who got provisional admission in college not of choice and have applied to participate in 2nd counseling shall be considered.
20. The candidate who has allotted the seat in the **second** merit list will submit his/her fee as per provision given above and will report to the college for verification of document

physically..

21. The applicant whose admission is confirmed shall submit his/her original migration certificate in the college as per guidelines, if he/she has passed the qualifying examination from any other University other than Gurugram University, Gurugram.
22. The candidate shall report to the allotted college on the date as per admission schedule with all relevant original documents for the physical verification.

Note:

Aadhar Number, Mobile Number, Photo and Date of Birth are mandatory for every student as the same is required by the UGC for uploading the results of students for online verification. Student himself/herself will be responsible for providing the correct information.

Guidelines for Colleges

1. All the colleges have to **upload their prospectus/information booklet (Program**

Eligibility, fee structure and seat matrix) on the college website and to provide the link to the University.

2. Colleges have to ensure that online verification shall be conducted for admissions strictly as per admission schedule.
3. **Parivar Pehchaan Patra (PPP)** shall be required for registration towards admission for Haryana residents.
4. Fee Structure shall be as per affiliating University/State Government norms.
5. The State Reservation Policy shall be followed in letter and spirit.
6. **First and Second lists will be generated by the University followed by open counseling at college level.**
7. **Online Documents Verification** shall be carried out by the college opted as first choice by the applicant. All colleges including Govt. Colleges, Govt. Aided Colleges, Private and Self- Financing Colleges shall be included during the process of Online Documents Verification.
8. If any discrepancy is found in the submitted application form of student due to any reason during the online verification process, the verifier (college) will mark the application as '**RESUBMISSION**' and enter the reason with Remarks Column. A SMS and Email will be sent to the applicant with remarks to clear the objection within prescribed time frame. The applicant will be required to make necessary corrections on the University online admission portal by logging in his/her account. If candidate fails to remove the discrepancy or resubmit the application within prescribed time frame the form will be rejected.
9. Merit lists shall be prepared after considering marks of qualifying examination as per State Reservation Policy.
10. The candidate shall be allotted the seats according to merit list and preferences filled by the students.
11. The candidate shall report to the allotted college on the date as per admission schedule with all relevant original documents for the physical verification.
12. After physical verification the college will verify the same on University web portal. The student has to submit his/her annual fee at the allotted college/institute at the time of reporting in allotted college/institute on the same day or as mentioned in admission

schedule.

13. In case student fails to produce original documents the admission shall be treated as cancelled.
14. In case student fail to deposit his/her fee, the allotted seat will be treated as vacant seat and will be offered to the next candidate during the preparation of second.
15. **Choice filling cannot be changed; it will be as filled in application form.**
16. Before preparation of 2nd merit list, provisionally admitted student will be given a chance if he/she is not satisfied with the allotted college (the applicant did not get his first choice) and want to consider his/her candidature for upgraded college as per his/her choice. This choice to participate in 2nd counseling is to be filled online through university web portal within prescribed time frame only.
17. In 2nd merit list, all the candidates (i) who did not get any seat during 1st merit list (ii) those who got seat allotted but could not get admitted due to any reason and (iii) candidates who got provisional admission in college not of choice and have applied to participate in 2nd counseling shall be considered.
18. The candidate who has allotted the seat in the second list will submit his/her fee as per provision given above and will report to the college for physical verification.
19. The applicant whose admission is confirmed shall submit his/her original migration certificate in the college as per guidelines, if he/she has passed the qualifying examination from any other University other than Gurugram University, Gurugram.
20. Timely submission of Registration Return in the University shall be ensured by the Colleges.
21. **The web portal for submission of Registration Returns and Continuation Registration Returns will be opened by the University *w.e.f.* date of admissions and will be closed as decided by the Registration & Scholarship Branch.**
22. **The last date to submit RR shall be 15 days to the last date of admissions as notified by the University.**
23. The colleges shall ensure that seats be filled according to norms only.
24. The refund, if any, shall be made to the student on the recommendation of Principal of the concerned college as per UGC guidelines.

25. Registration on Online Admission Portal of Gurugram University, Gurugram is mandatory for admission seekers. In no circumstances, admission without registration on University portal shall be allowed.

26. Declaration to be obtained from the candidate

The College/ Institute should make a provision in the admission form for a declaration to be given by the student(s) as under: -

"I declare that I am applying for admission with the consent of my parents/guardian and that the particulars given above are correct. I have read the College / Institute Admission guidelines for the session 2025-26 as well as the admission requirements as laid down by the University for the course. I agree to abide by the rules and regulations given therein. I further declare that I shall submit myself to disciplinary jurisdiction of the Principal/Director of the College/Institute, the Vice-Chancellor and the other authorities of the University who may be vested with the power to exercise discipline under the Act, the Statutes, the Ordinances and Rules framed by the University in this regard.

I understand that my admission if made by the College/ Institute is provisional and will be subject to confirmation by the University. In case my admission is cancelled by the University I shall have no claim for refund of fees paid by me to the College/Institute or the University.

I undertake that I shall not indulge in any act of ragging otherwise my admission to the College/Institute shall stand cancelled and disciplinary proceedings be initiated against me."

The applicants shall also submit the Undertaking as **appended at 'N'**.

27. Students, in any case, will not be dealt with directly by the University and their requests/applications should not be sent to the University in piece meal. However, the doubts, if any, may be got cleared by deputing an official/teacher to the University.

28. The total number of seats in the erring College(s)/Institute(s) committing any type of irregularity in making admissions etc. will be reduced by minimum ten seats initially for a period of one year and it will be doubled in case the College/Institute repeats the violation of rules.

29. The instructions for curbing ragging as conveyed by the UGC vide letter No. 1-15/2009 (ARC) pt. III dated 17.03.2017, in view of the judgment of the Hon'ble Supreme Court of

India dated 08.05.2009 in Civil Appeal No. 887/2009 be adhered to strictly (UGC Regulations on Curbing the Menace of Ragging in Higher Education Institutions, 2009, UGC website i.e. www.ugc.ac.in & the Haryana Prohibition of Ragging in Educational Institution Ordinance 2012.

30. Candidates who have passed their qualifying examinations from the Universities/Boards in the state of Haryana will be deemed to be Haryana residents and will not be required to submit certificate of residents of Haryana, however, **PPP will be mandatory.**

31. If gap in studies, students may give reasons with documentary proof/ self-undertaking.

32. The UGC vide its letter dated 26.02.2015 has issued guidelines to the University regarding scholarships meant for SC students, to incorporate in Prospectus/ Brochure of all the Institutes that the eligible SC students should submit their scholarship forms for the Academic year by February for processing scholarship to SC students each year. Therefore, all the Institutes are required to incorporate the instructions in their Prospectus/Brochure that the eligible SC /ST, OBC, PwD students etc. should submit their scholarship form for the Academic year by February for processing scholarship.

33. All the Colleges/Institutes shall add a column in the admission form/application form in the Prospectus of College/Institute of Transgender, Aadhar Card Number, Mobile Number and email address. As per instructions of the State Govt. issued vide Memo No. 18/30-2015 UNP (4) dated 08.03.2017, to enable to link Aadhar ID with Bank account of all students to be admitted from the session 2018-19, the Aadhar based admissions must be implemented i.e. every student shall be in possession of Aadhar number at the time of admission in the College

34. The refund of fee shall be as per the latest notification of University Grants Commission.

35. The students will be initially given provisional admission only, subject to the verification of their documents by the College/Affiliating University. In case of any discrepancy, the college is authorized to cancel the provisional admission of the student or change his/her stream/subjects subject to availability of seats & his/her willingness.

36. The List of Self-styled Institutes/Universities which have been declared Bogus by the University Grants Commission is at **Appendix-K**.

Guidelines for Physical Open Counselling

1. **Physical/Open counseling will be held in duration as mentioned in admission schedule.** Programme wise comprehensive waiting list of all interested applicants along with phone numbers will be provided to the respective colleges.
2. College will conduct open physical counseling at their own level to prepare and **display the merit list (daily basis, if required)** as per affiliating University/Government norms. The account of filled/vacant seats (category-wise) shall be managed by colleges only during Physical Open Counseling. Reservation policy shall be implemented in letter and spirit.
3. Candidate has to pay **the fee on the same** day or as per the admission schedule at the allotted college/institute at time of reporting in allotted college/institute.

Note: *The college shall ensure the eligibility checking and document verification w.r.t. the student. A declaration to this effect will be taken from the colleges that the application form along with supporting documents has been verified and the student is found eligible as per norms.*

CHAPTER-V

RESERVATION OF SEATS

Note: The reservation of seats is as per Reservation Policy of the State Govt. of Haryana and is subject to change/amendment made by the State Govt. from time to time.

- i) Candidate belonging to SC/ST are required to submit a certificate from the competent authority as per **Appendix-A**. The list of Deprived Scheduled Castes notified by the Haryana Government, is available at **Appendix-H**.

- ii) Candidate belonging to Backward Classes are required to submit a certificate from the competent authority as per **Appendix-B**. The list of Backward Classes in Haryana notified by the Haryana Government is available at **Appendix-I**.
- iii) The children or grandchildren (Maternal & Paternal) of Freedom Fighters are required to submit a certificate form the competent authority as per **Appendix-C and Appendix-D** in case of Deceased/Disabled/Discharged Military Personnel/ Serving Military Personnel/ Ex-Servicemen.
- iv) In the event of quota reserved for Physically Handicapped (required to submit a certificate form the competent authority as per **Appendix-E**) remain unutilized due to non-availability for suitable category of handicapped candidates, it may be offered to Ex-Servicemen and their wards (1% and the dependent of Freedom Fighter 1%).
- v) Further, 3% reservation is also provided to Ex-serviceman/ Freedom Fighter and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned year wise rotational system will be adopted. For example, if Block-A of Backward Classes are given seats in academic year 2013, the next Block i.e. (B) Block of Category of Backward Classes will be given seats in the next academic year 2014 and so on.
- vi) Fifty percent of the twenty percent seats reserved for Scheduled Castes for admission in any educational institution shall be set aside for candidates belonging to deprived Scheduled Castes as enumerated in the **Appendix-G and H**.

Note:

A roster register for reservation of seats for ex-servicemen/freedom fighter shall be maintained and carry forward all fractions till one seat is accumulated through different fractions over the years. As and when the total comes to one, a seat will be provided in the Prospectus (Chief Secretary to Govt. Haryana letter No. 23/27/2004-2GS-III dated 05.12.2008).

2. **Guidelines for Reservation**

- i) A candidate who applies for a reserved category or for both reserved and general categories will be considered first in general category. In case, he is not selected in general category, he/she will be considered for reserve category.

The Scheduled Castes/Backward Classes candidates who get selected /admitted in Educational/Professional/Technical Institutions and Universities in open competition on the basis of their own merit, will not be counted against the quota reserved for scheduled caste/ backward classes, rather they will be treated as open competition candidates. However, such candidates shall fulfill condition of eligibility regarding age etc. as are meant for general category candidates (Memo No.13864-75 dated 24.8.2012 received from the Principal Secretary to Govt. of Haryana, Welfare of Scheduled Caste and Backward Classes, Department, Chandigarh).

- ii) Benefit of reservation will be given to all the reserved categories upto 2nd counseling according to the reservation policy given in the Guidelines. In case at the time of third counseling/open counseling the reserved seats of various categories remain vacant and no eligible candidates of the reserved categories are available, these vacant seats may be thrown open to Haryana General Category. In case, the seats in Haryana General Category remain vacant at the end the same will be thrown open to All India Open Category
- iii) If any seat remains vacant in sub-categories of BC(A) and BC(B), the same will be filled up through the candidates belonging to other category. For example, if any

seat in BC(B) category remains vacant, the same will be filled up from BC(A) category and vice-versa.

- iv) If any seat remains vacant in sub-categories of SC, the same will be filled up through the candidates belonging to other category. For example, if any seat in SC category remains vacant, the same will be filled up from Deprived SC category and vice-versa after 2nd counselling.
- v) Where a seat set aside for candidate from deprived Scheduled Caste for admission in Government educational Institutions is not filled up in any academic year due to non-availability of candidate of deprived Scheduled Castes possessing the requisite qualifications, the same shall be made available to candidate of Scheduled Castes.
- vi) A candidate having a minimum of 40% permanent disability will be considered physically handicapped for admission to a course, provided that the candidate is otherwise medically fit for the particular course. Such candidate will be admitted to the relevant courses on the basis of academic merit and not on the basis of degree of handicapped. Certificate should be as per **Appendix- 'E'**.
- vii) Children or Wards of Military Personnel (including personnel of Para-Military Forces killed in Action or Permanently Disabled in Action and Boarded Out from the Services or Ex-Servicemen and their wards will be considered of reservation. They will submit a certificate as per **Appendix-'D'**. The following categories of personnel of Territorial Army are included in the definition of Ex-Servicemen in terms of the State Govt. Letter No. 12/18/2006-GS-II dated 08.01.2008.
 - i) Pension holders for continuous embodied service

- ii) Persons with disability attributable to military service
- iii) Gallantry Award Winners and
- iv) Such recruits boarded out/released on medical grounds and granted medical/disability pension.

CHAPTER-VI

7.1 BAN OF RAGGING IN EDUCATIONAL INSTITUTIONS

The instructions for curbing ragging as conveyed the UGC vide letter No. 1-15/2009 (ARC) pt. III dated 17.03.2017, in view of the judgement of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009 and also given in Chapter X be adhered to strictly (UGC Regulations on Curbing the Menace of Ragging in Higher Education Institutions, 2009, UGC website: www.ugc.ac.in & the Haryana Prohibition of Ragging in Educational Institution Ordinance 2012.

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately. The punishment may include expulsion/ suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding or withdrawing scholarships or fellowships and other benefits (ii) forfeiting campus placement opportunities or recommendations. (iii) debarring from appearing in any test or examination or other evaluation process (iv) debarring from representing the educational institution in any regional, national or international meet, tournament, youth festival, etc. (v) withholding results (vi) suspension or expulsion from hostel or mess (vii) cancellation of admission (viii) lodging of FIR with the local police. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or in disciplinary activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear apprehension thereof in freshers or junior students or asking the students to do any act or perform something which such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame of embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student or any type of abuse through electronic media or wrongful confinement, use of criminal force, assault as well as sexual offence, trespass, defamation or threat to defame will be deemed an act of ragging.

Hon'ble Supreme Court of India in SPL (C) No. 24295/2004 in the matter of University of Kerala V/s Council of Principals, Colleges of Kerala and others has ordered that if any

incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain to if his/ her explanation is not found satisfactory, the authority would expel him/her from the Institution.

As per letter of UGC vide D.O. No. 1-15/2009(ARC)PT.III dated 12.06.2023 the procedure of Anti-Ragging Undertaking & Compliance Submission has been revised and is completely online and student is not required to submit any hard/printed affidavit in the University/Affiliated Colleges.

The Affiliated College are directed to follow the revised procedure for students to fill online undertaking and also submit Anti-Ragging compliance form on www.antiragging.in and to submit the compliance. The anti-ragging poster is to be displayed on prominent places of the College campus.

7.2 Check on the menace of sexual harassment and violence against women

The University has a zero tolerance policy towards the act of sexual harassment. Sexual harassment is taken as a serious act of indiscipline. A Committee, constituted by the Vice-Chancellor under the Chairpersonship of a senior female professor/Associate Professor, will check the menace of sexual harassment and violence against girl students and women. The Sexual Harassment|| includes any unwelcome sexually determined behaviour, whether directly or by implication and includes physical contact and advances, a demand or request for sexual favours, sexually-coloured remarks, showing pornography or any other unwelcome physical, verbal or non-verbal conduct of sexual nature. The Committee shall take all precautionary measures to prevent sexual harassment and violence against girl students and women in the University. It shall also ensure that there is no hostile environment towards girl students and women. No girl student should have reasonable ground to believe that she is at a disadvantage or is being discriminated against. If any complaint of sexual harassment comes to the notice of the Committee, immediate disciplinary action alongwith appropriate action in accordance with the law would be taken.
